- I. PRICE.** We at North Carolina Furniture For Less are a discount company and are committed to finding you the best possible price for your furniture, either by ordering directly from the manufacturer or through a distributor or other company.
- II. ORDERS.** All orders are confirmed in writing. Please check for accuracy. Unless notified, your order will be delivered as written. Furniture is NOT ordered on a trial basis.
- III. DEPOSIT.** Once you have made your selection, your order will be initiated with a 50% deposit by personal check, Visa, MasterCard or Discover. The balance is payable when order is received at our delivery service.
- IV. REFUNDS.** This order is NOT cancelable and the deposit is NOT refundable since this is a special order.
- V. DAMAGES.** IT IS THE BUYER'S RESPONSIBILITY TO INSPECT ITEMS THOROUGHLY WHILE DELIVERY SERVICE IS PRESENT. Most damage is minor and can be corrected by ordering replacement parts; however, some damaged items must be repaired or replaced by our delivery service and must be returned to them.
